The latest organizing victory was with the ALSCO RSR drivers in Charlotte. The RSR Drivers voted overwhelming for Teamsters Local 71 representation. Local 71

already represented one facility in Charlotte and now will represent both.

Ted Russell President of Local 71 said, "In these hard times, these drivers, after talking with other ALSCO drivers, have seen the value of a Teamster Contract with better wages, benefits, job security and job protection for them and their families."

Local 71 Organizer Randy Conrad said, "Our Secretary-Treasurer and BA Ernie Wrenn, ALSCO Shop Steward Joe Robertson, and myself met with the drivers and they made up their mind in the very first week of the campaign that being a Teamster is what they wanted and nothing was going to change their mind.

Organizer Conrad, who organized another ALSCO facility 3 years ago in Greensboro, NC also said, "I had the honor again in working with the Bakery and Laundry Conference. This is such a great conference".

Wrenn said, "much appreciation and thanks goes to Dennis Raymond the International Director, Dave Dudas, and Tyronne Brewster for their work they do in the conference, their commitment to organizing, and their assistance. Locals from Florida, to Georgia, to Virginia and all the way to Alaska gave their support with pictures and support petitions".

Russell and Wrenn added, "we are very pleased with Local 71's Organizing Department as our organizing machine rolls on with our 3rd victory with-in a year."

Both Business Agents are also reminding all their members to bid on your scheduled bid day. If you miss it you have to bid from what is left at the time you bid.

Unions Under Attack In South Carolina

After only being in office for about a week, Gov. Nikki Haley of SC has been quoted that it's no secret that she doesn't like Unions. Her past history backs it up by being with an anti-union law firm and practicing union avoidance for over 14 years. She is now being sued and taken to court by some unions and the AFL-CIO because of remarks she made vowing to keep Unions out of a Boeing plant that is presently under construction in North Charleston, SC. She has vowed to do everything she can to be pro-business and defend the fact that SC is a right to work state. We will keep our members informed as information becomes available.

Your Weingarten Rights



Yes, You Have RIGHTS! If you are called into a meeting with any management representative and have reason to believe that disciplinary action may

result, read them your Weingarten Rights. WEINGARTEN RIGHTS

If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my Union representative or Steward be

present at this meeting.

Without representation, I choose not to answer any questions.



In 1975, the U.S. Supreme Court ruled, in the

WEINGARTEN decision,

that an employee is entitled to have a Union representative present during any interview which may result in his or her discipline. It is up to YOU to insist on Union representation. If you fail to do so, you may waive your rights.

Do The Following:

1. Ask your supervisor if you might be disciplined as a result of the interview. If he says "NO," ask for a written statement to that effect. If he gives you such statement, you must participate in the interview. If not, read him your Weingarten rights, remain for the meeting, take notes, and afterwards immediately contact your Union representative.

2. If he says you might be disciplined but will not allow you to have a Union representative present, read him your Weingarten rights, stay in the room, take notes, and do not respond to any questions. Afterwards, contact your Union representative immediately. If he allows your Union representative to be present, you should participate in the interview.
